9. A Phase I - preliminary plan for the watershed of the Gile Flowage as part of larger smart growth planning efforts.
10. A steering committee of stakeholders meeting regularly.

(Future phases will allow more detailed data collection on the Gile Flowage.) This phase is to look at what is available, develop a framework and begin the process of bringing diverse stakeholders together.
