The project includes the following goals: 1) Early season AIS survey; 2) Hand removal coordination and GPS base map creation; 3) Volunteer based surveillance monitoring and hand removal; 4) Late summer follow up AIS survey.

Project deliverables include: 1) Annual AIS monitoring report; 2) A final report will be completed discussing the results of the three years of surveys, success of hand pulling and a control strategy targeting AIS within Lake Mohawksin.
