Project deliverables include: 1) Estimated 900-1000 paid and 270 volunteer watercraft inspection hours; 2) Entered inspection and monitoring data into SWIMS; 3) Assembled AIS information and newsletter article(s); 4) Final report summarizing inspection activities, monitoring, and AIS educational activities.
