The purpose of this project is to reduce the amount of pollutants originating from nonpoint sources that reach surface water and groundwater within the project area.
Objective: The primary objective of the project is to reduce nonpoint source pollution to the surface water and groundwater, and to enhance and protect the water quality of streams in the Horse Creek Watershed.
Comments:
Outcome: The project goals are to maintain and protect shoreline buffers, reduce total phosphorus in several lakes, maintain and protect water quality, reduce in-stream sedimentation and in-stream habitat loss, and form a lake association or district in cooperation with all the lakes in the watershed.
