Project activities include: 1) Conduct annual early-season AIS and peak-biomass surveys; 2) Conduct PI survey; 3) Volunteer AIS monitoring; 4) Control EWM by professional and volunteer hand removal efforts; 5) Develop annual maps and letter report.

Project deliverables include: 1) EWM and PI survey data and maps; 2) Annual letter report describing the findings of the early-season survey, peak-biomass survey, hand-pulling efforts, and guidance for continued control actions.
