Purpose: The Clean Lakes Alliance is sponsoring a project to update the previous Yahara CLEAN watershed plan for Lake Mendota with the following goals: reconvene planning partners to a) update the 2012 watershed plan; b) include a timeline for achievement of specific goals, identify resource gaps, make recommendations on communication to the public, evaluate funding improvements, and after department review of draft survey, conduct a social survey to assess attitudes and behaviors; and c) create a partnership compact to formally adopt the plan with defined roles and expectations. Public input opportunities will be provided. Project deliverables include an updated watershed nutrient reduction plan including outreach and funding recommendations that can be formally adopted by Yahara CLEAN partners. Specific project conditions: The department must review a draft social survey instrument prior to the survey being finalized and disseminated.
