Project final deliverables include: a final summary report and all data entered in the SWIMS database.

Specific project activities include: 1) Inventory riparian invasive species along creeks, streams and adjacent private properties within Door County and share inventory data through Door County Web Map and SWIMS; 2) Chemically treat phragmites using aquatic approved herbicides; 3) Monitor treatment sites to determine success and follow-up needs; 4) Promote invasive species awareness throughout Door County and provide education and outreach to riparian landowners along and adjacent to streams being inventories and treated; and 5) Develop a final report summarizing the overall project results.
