Project activities include: 1) Recruit volunteers and implement a CB/CW program at town landings; 2) Hire CB/CW coordinator; 3) Conduct AIS citizen lake monitoring following Dept/UW Ext guidelines (two Adopt-A-Shoreline sweeps); 4) Maintain zebra mussel monitoring stations; 5) Entry of inspection forms 3200-120 and monitoring Forms 3200-124 onto Dept website; 6) Create and distribute CB/CW lures; 7) Disseminate AIS information at boat landings, public areas, and businesses.

Project deliverables include: 1) Completed entry of inspection 3200-120 and monitoring Forms 3200-124 onto Dept website; 2) Sample lure; 3) AIS educational materials; 4) Final report summarizing CB/CW activities, AIS monitoring, and AIS educational activities.
