Project activities include: 1) Recruit volunteers and implement a CB/CW program at town landings; 2) Hire two CB/CW inspectors; 3) Host three CB/CW trainings and a Citizen Lake Monitoring & AIS ID training; 4) Conduct AIS citizen lake monitoring following Dept/UW Ext guidelines; 5) Entry of inspection forms 3200-120 and monitoring Forms 3200-124 and/or 3200-130 onto Dept website; 6) Send AIS Coordinator and Conservation Specialist to Lakes Convention; 7) Develop AIS Webpage; 8) Provide incentive patches to dedicated volunteers; 9) Create and distribute placemats to area businesses.

Project deliverables include: 1) Completed entry of inspection 3200-120 and monitoring Forms 3200-124 and/or 3200-130 onto Dept website; 2) Completed AIS Webpage; 3) Incentive patches; 4) AIS placemats; 5) Final report summarizing CB/CW activities, AIS monitoring, and AIS educational activities.
