Specific project activities include: 1) In-Lake and tributary monitoring; 2) Shoreline monitoring; 3) aquatic plant surveys; 4) Lake level and precipitation monitoring; 5) watershed delineation and modeling. 6) sociological survey; 7) Largon Lake booklet

Special Conditions: 1) CLMN efforts should not be duplicated, and these data shall be included in the trends analysis and final reporting; 2) All data shall be entered into the SWIMS database; 3) Draft user surveys must be approved by the Department before being initiated; 4) All monitoring shall follow DNR approved protocols. 5) WDNR\2019s Aquatic Plant Management in Wisconsin guidance shall be followed for aquatic plant monitoring and management plan development. The NOR Native Plant Protection Strategy shall be integrated into the plan.
