Squash Lake PRD is sponsoring a project to implement approved Eurasian watermilfoil (EWM) control activities from their aquatic plant management plan.

Project activities include:

- 1) Conduct early and late season AIS mapping surveys (for EWM) and aquatic plant point-intercept survey;
- 2) Annual DASH and professional hand-harvesting of EWM;
- 3) Develop annual and final AIS monitoring and control strategy assessment reports;
- 4) Conduct Clean Boats, Clean Waters (CBCW) watercraft inspections.

Project deliverables include:

- 1) Harvested EWM and associated aquatic plant management permit reporting;
- 2) Data from aquatic plant surveys;
- 3) Annual and final AIS monitoring and control strategy reports summarizing EWM management and monitoring during project and future EWM management direction;
- 4) CBCW data entered into DNR SWIMS database.
