Purpose: Fish Lake Management District proposes to control Eurasian water-milfoil (EWM) in Fish Lake by implementing control measures during the period 2010-2015. The project elements and deliverables are specified in the Fish Lake Management District\2019s Aquatic Invasive Species Control Grant application, dated March 3, 2010. The project includes conducting pre- and post-treatment surveys, including a full Point Intercept survey, and mapping the extent of EWM; controlling EWM with aquatic herbicide treatments; and implementing an aquatic invasive species prevention strategy that includes developing an information & education program. Annual progress reports and a final report summarizing the one-year project will be provided to DNR.
