Project activities include: 1) Conduct point-intercept (PI) aquatic plant and early-season AIS surveys; 2) Conduct volunteer AIS monitoring; 3) Control CLP and purple loosestrife by hand removal efforts; 4) Conduct watercraft inspections; 5) Enter watercraft inspection data into SWIMS; 6) Purchase GPS; 7) Develop annual maps and letter report.

Project deliverables include: 1) PI and early season AIS survey data and maps; 2) Entered inspection data; 3) GPS; 4) Letter report describing the findings of the PI survey, early-spring survey, hand-pulling efforts, and guidance for continued CLP control actions.
