Project deliverables include: 1) EWM survey data and maps; 2) Entered inspection data; 3) GPS; 4) Annual and final report describing the findings of the EWM surveys, EWM challenge testing, watercraft inspections, volunteer monitoring, and guidance for potential EWM control actions.
